NOTES FROM THE STEWARDS
RACEDAY 16
SATURDAY 19TH MAY, 2018.

STIPENDARY STEWARDS: RICHARD HALFHIDE DAVID LOREGNARD RICHARD FREEMAN

RACE 1

Jockey R. Ali rider of **#3 REDHOTFILLYPEPPER**, placed fourth, objected to **#7 DATSAMORE**, placed third, ridden by W. Leon for foul riding in the last 600 metres.

Having seen the video replay and heard the jockeys' evidence, the Stewards noted that **#10 PEARL SECRET**, the winner, ridden by N. Mohammed drifted in slightly as the horses negotiated the 600 metre bend. This action caused **DATSAMORE** in turn to drift inward and **REDHOTFILLYPEPPER** to be momentarily checked. The Stewards were satisfied that the eventual result was not affected and overruled the objection.

The Stewards permitted a change of rider on **#1 MARY'S GIRL CHILE** subject to jockey N. Samaroo being paid his riding fee and be eligible for commissions.

The Stewards noted that **#6 UNGUARDED MOMENT** was slowly away.

The Official Veterinarian reported that **#1 MARY'S GIRL CHILE** returned lame on the left hind (Grade 4).

RACE 2

The Stewards noted that **#5 MORNING BREEZE** was slowly away.

The Official Veterinarian reported that **#4 UNSTOPABLE** hit his head in starting gates and was withdrawn.

Jockey L. Keizer rider of **#3 ROCKIN ANILEY**, unplaced, objected to **#11 UNO MAS**, placed fourth, ridden by N. Patrick for crossing around the 600 metre mark. Having seen the video replay and heard the jockeys' evidence the Stewards noted that **ROCKIN ANILEY** was checked slightly as **UNO MAS** went by. The Stewards were satisfied that the eventual result was not affected and allowed the placings to remain unchanged.

The Official Veterinarian reported that **#3 ROCKIN ANILEY** returned lame on the left fore (Grade 3).

RACE 5

Jockey Y. Serrano rider of **#5 WAKA WAKA**, placed second, objected to the winner, **#3 AGAINST THE ODDS**, ridden by N. Abrego for foul riding around the 600 metre mark. Having seen the video replays and heard the riders' evidence the Stewards saw no reason to take any action.

The Stewards ordered that **#12 CALIBURN** be routine tested.

The Official Veterinarian reported that **CALIBURN** returned lame on the left fore (Grade 3).

RACE 6

The Starter reported that **#2 GOLDEN CHOICE** refused.

Jockey N. Samaroo was fined **\$250.00** for improper use of the whip on **#3 SUNSET CLOUD**.

RACE 7

The Stewards noted that **#2 ROCK IN PEACE** stumbled at the start.
