RACE 1

Jockey B. Boodramsingh rider of **#2 MISS MANAGEMENT**, the winner, reported that horse **#4 SEA DOG**, ridden by jockey R. Ali, placed second, came across sharply after leaving the gates causing him to check his mount slightly. He advised that he recognised that it was the horse's first race and was very green in its performance. His comments were noted.

The Stewards upon viewing the video replay considered his comments to be reasonable in the circumstances.

RACE 2

The Stewards upon review of the video replay observed that **#6 CALIBURN**, ridden by apprentice R. Balgobin, unplaced, was eased in the final **200** metres. Apprentice Balgobin advised the Stewards that his mount stumbled about three times in the race and was unsteady indicating that it may have been feeling something. He considered it dangerous to continue riding out the horse and eased it up accordingly.

Jockey R. Ali rider of **#4 WELL CONNECTED**, unplaced, was asked by the Stewards to comment on the performance of his mount. Upon review of the video replay the Stewards noted that the horse fell back sharply after reaching the bend approaching the homestretch. Jockey Ali stated that the horse ran only for the first **600** metres after which it failed to respond to his urgings. His comment was noted.
