RACE 1

The Starter reported that **#4 WYATT EARP** refused under orders.

The Official Veterinarian reported that **#9 BIG CUT** returned lame on the right fore (Grade 3.)

RACE 2

Jockey D. Blackman rider of horse **#7 BRIDAL FALLS**, unplaced, objected to apprentice J. Boodramsingh rider of horse **#9 FORTUNE TELLER**, also unplaced, for interference in the final **200** metres in the home stretch.

The Stewards interviewed the jockeys and reviewed the video replays and observed that **FORTUNE TELLER** drifted out against **BRIDAL FALLS** causing jockey Blackman to check his mount.

Apprentice Boodramsingh was found guilty of careless riding and was fined **\$200.00** by the Stewards. Placings were ordered to remain unchanged and the objection was overruled.

The Official Veterinarian reported the following:

- (1) **#2 BURNING DESIRE** bled externally indicative of **E.I.P.H.** and is not to race until **10.11.2018**;
- (2) **# 11 ILLEGAL PRINCE** returned lame on the right fore (Grade 3); and
- (3) **#13 ASIAN PRINCESS** bled externally indicative of **E.I.P.H.** and is not to race until **10.11.2018**.

RACE 3 N I L

RACE 4

Jockey R. Jadoo rider of **#2 LOMBARD STREET**, placed second, objected to jockey R. Ali rider of **#14 TOWERING**, the winner, and apprentice A. Poon rider of **#8 UNSETTLED**, placed third, objected to jockey R. Jadoo for interference both objections being at the 100 metre mark.

The Stewards interviewed the jockeys and viewed the video replays and observed that **TOWERING** drifted in causing **LOMBARD STREET** to drift into **UNSETTLED** which was on the inside against the rail causing it to check thereby losing second place.

The Stewards found jockey Ali guilty of careless riding and fined him **\$500.00** for the offence but ordered the placings to remain unchanged as they considered that infringement did not improve the chances of the winner.

RACE 5

The Starter reported that **#7 SORAYAH** refused under orders.

Apprentice O. Mohammed rider of **#5 BLUE MOUNTAIN ROSE**, unplaced, objected to jockey N. Edwards rider of **#3 VEINS OF GOLD**, also unplaced, for interference around the 900 metre mark.

The Stewards interviewed both jockeys and viewed the video replays but did not consider that jockey Edwards was guilty of any offence and overruled the objection.

RACE 6

The Official Veterinarian reported that both **#3 ONETOUGHCOOKIE** and **#8 SAMURAI** reared, fell and hit their backs and were withdrawn at the starting gate.

RACE 8

Jockey A. Poon appointed rider of **#3 TIGER'S EYE** was declared unfit to ride prior to the start of the race and as there was no other available jockey to ride this horse it was withdrawn.

Trainer Glenn Mendez was fined **\$100.00** for the late arrival in the parade ring on **#4 INTEGRITY**.
