Stewards' Observations/Objections & Decisions

The Stewards received a request from Jockey, **N.FLAVENNEY**, who was claiming riding fees and commissions due for Race 6, #4, **REGAL INTENSION**. The Stewards interviewed both Trainer, **G.MOHAMMED** and Jockey, **N.FLAVENNEY**. Jockey, **N.FLAVENNEY**, was double booked in Race 5 and informed Trainer, **G.MOHAMMED** that he would be riding horse #1, **SEA OF GDANSK** instead of #4 **MAFIA MAN**. The Trainer, after consulting with the Owner, replaced Jockey, **N.FLAVENNEY**, on #4, **MAFIA MAN** in Race 5 and #4, **REGAL INTENSION** in Race 6. These changes were made before 9a.m. on Wednesday morning in accordance with the conditions of Entry/Declarations. The Stewards therefore denied Jockey, **N.FLAVENNEY**'s request for riding fees and commission on #4, **REGAL INTENSION**.

The Stewards summoned Jockey, **K.Santo** after the race regarding his premature celebration before the winning pole. Jockey, **K.Santo** was severely cautioned and advised that a repeat performance would result in harsher penalties.
