Stewards' Observations/Objections & Decisions:

The Stewards received a report from Trainer, **GLEN MENDEZ**, on Wednesday February 23rd. 2022 regarding the tampering of **GREAT HEART**. The Trainer also indicated at this time his intention to race the horse on Race Day 4, Saturday February 26th. 2022. The Stewards advised the Official Veterinarian to examine the horse on the said day and report the findings. The Stewards requested that the Official Veterinarian take a blood sample for testing. After consultation, the panel of Stewards decided to scratch **GREAT HEART** from Race 2 on Race Day 4. The Trainer was advised of the Stewards' decision, with reference to Rule 104A. "It is the duty of the Stewards to ensure the integrity of horse racing, to guard the health of the horse and to safeguard the interests of the public and racing participants through the prohibition or control of all drugs, medications and drug substances foreign to the horse".
