Stewards' Observations/Objections & Decisions:

The Starter reported that horse #3 ARSALAN had to be resaddled at the start.

The Stewards held an enquiry into the collapse of the rails between the 800 metre and 600 metre marks. Upon viewing the replays the Stewards observed that **#2 ATALANTA** hit the rails causing it to collapse.

Jockey N. Flavenney, rider of **#2 ATALANTA**, lodged an objection against an unidentified horse for interference. On viewing the video replays the Stewards observed that horse **#6 GREAT HEART**, ridden by R.Jadoo was drifting inwards unto **#5 SEA OF GDANSK**, ridden by J. Boodramsingh. However, because of the extremely poor video quality the Stewards were unable to determine if this was the cause of any possible infraction. The Stewards therefore overruled the objection and declared the race official. Out of an abundance of caution, the Stewards decided to move Race 6 from the Turf to the Main Track.
