Stewards' Observations/Objections & Decisions:

The Stewards received the following objection:

Jockey B.Boodramsingh, rider of **#1 MIDNIGHT LOVER**, unplaced, objected to Jockey R.Balgobin, rider of **#3 PROUD VANESSA**, the winner, for foul riding within the last 200 metres. The Stewards reviewed the video replays and interviewed both Jockeys. The Stewards observed that **PROUD VANESSA** was lugging in towards the rail despite the jockey having the whip in his left hand and trying his best to control his mount. The Stewards also observed that there was no contact between the horses, which was confirmed by both Jockeys. The Stewards therefore overruled the objection and declared the race official.

The Stewards enquired into the riding of horse **#7 ATTA GIRL SILVY** in the homestretch. Jockey A. Poon stated that his mount clipped heels entering the first turn and he did not persevere with his mount. His explanation was noted. Jockey A. Poon was reminded of his obligation to obtain the best possible placing at all times.

The Official Veterinarian reported that horse **#1 MIDNIGHT LOVER** returned lame on the left forelimb Grade 3.
