Mohammed** explained that the saddled slipped during the race and he could not ride out his mount fully hence the reason he kept looking around for the opposition. The stewards upon reviewing the video, observed and confirmed that the saddle slipped during the race. His explanation was noted.

The Stewards received the following objection: **Jockey, D.Khelawan** rider of **#1, COUNTRY SIGN**, placed fourth, objected to **Jockey, O. Mohammed**, rider of **#2, PROUD VANESSA**, winner, for foul riding around the 900m mark. After interviewing the jockeys and viewing the video replays, the Stewards found no reason to take any action, overruled the objection and declared the race official.
