Blackman rider of #7, MAHA RAJA, placed eighth, objected to Jockey, N. Flavenney, rider of #5, MAFIA MAN, placed third, for foul riding between the four and six hundred meters mark. After interviewing the jockeys and viewing the video replays, the Stewards found no reason to take any action, overruled the objection and declared the race official.

#7 KOBE refused under starters orders. The starter informed the stewards that #7 KOBE must be reschooled and recertified before taking entry. The Stewards received the following objection: **Jockey, O. Mohammed** rider of #6, SHE WBO ON TIME, placed third, objected to **Jockey, N. Mohammed**, rider of #5, QUASIMOTO, placed eighth, for crossing at the start. After interviewing the jockeys and viewing the video replays, the Stewards found no reason to take any action, however **Jockey, N. Mohammed** was severely cautioned to maintain a straight course at the start of a race. The stewards overruled the objection and declared the race official. The Official Veterinarian **Dr. D. Brailey** reported # 9 MAN ON FIRE returned lame on the **Right Fore Limb (Grade 3)** and was subsequently placed on the Veterinarian's List.
