Stewards' Observations/Objections & Decisions:

The Stewards interviewed **Trainer Ramesh Ramroop** based on correspondence received from T.T.R.A. whereby the Equine Influenza Vaccines were not current at the time of entry for horses #3 QUASIMOTO and #4 THUNDERBIRD. After interviewing **Trainer Ramroop** the Stewards ordered the withdrawal of both horses in accordance of Rule 31 (9) (f). The Official Veterinarian reported that #5 PURE STRIKE & #7 D'HUMMINGBIRD returned Lameness Right Fore Limb (Grade 3) & Lameness Right Hind Limb (Grade 3) respectively.
