Stewards' Observations/Objections & Decisions: The Stewards called an inquiry into the running of the race. The Stewards received the following objection, **Jockey T. Phillips**, rider of **#5, ARSALAN** objected to **Jockey D. Khelawan**, rider of the winner **#3 C'EST LA VIE** for foul riding in the final 300 meters. The Stewards reviewed the video in the presence of both jockeys and they were interviewed. Jockey **D.Khelawan** confirmed that his mount kept drifting out, despite his best urgings to keep a straight course and made minimal contact in final 200 meters. The Stewards were satisfied with his explanation, overruled the objection and declared the race official.

Stewards' Observations/Objections & Decisions: The Stewards received an objection, Jockey **O. Mohammed** rider **#4 EMPRESS HASSAN** objected against **Jockeys N. Abrego & T. Phillips** riders of **#3 ALPHA CENTAURI & #5 CRÈME DE LA CRÈME** respectively for crossing coming out of the gates. After viewing the video and interviewing the jockeys the stewards observed a general tightening up among horses **#2 JC PEYTON, #3 ALPHA CENTAURI, #4 EMPRESS HASSAN & #5 CRÈME DE LA CRÈME**. The Stewards deemed the interference accidental, overruled the objection and declared the race official.
