Stewards' Observations/Objections & Decisions:

The Stewards called an enquiry immediately after the running of this race, regarding the fall of Jockey **A. Daniel** from horse #1 ARSALAN. After reviewing the video footage, the Stewards observed Jockey **A. Daniel** reaching for his right stirrup, becoming unbalanced and unseating from his mount immediately after. The Stewards also observed that horse #1 ARSALAN was not impeded or hampered by any other horse in close proximity. The unseating of Jockey **A. Daniel** caused horse #3 MIDNIGHT LOVER to be severely hampered. The Stewards also interviewed Jockey **A. Daniel**, after he was attended to by medical personnel, and he confirmed that he was not hampered or impeded by another horse. The Stewards took no further action and declared the race Official.

### Stewards' Observations/Objections & Decisions:

The Stewards interviewed Trainer Keith Lucas regarding the use of an unlicensed groom in the saddling enclosure and having that groom lead horse #9 JCPEYTON in the Post Parade. Trainer Lucas stated that he was not aware of an unlicensed groom attending to horse #9 JCPEYTON. Trainer Lucas was reminded that any Trainer seeking assistance in the Parade Ring or Weighing Room from an unlicensed individual, needs to request an Official Pass from the Racing Office. The Stewards took into consideration the fact that an unlicensed groom led a horse in the Post Parade and the number of occasions that the Stewards had to summon and warn Trainer Keith Lucas of his negligence in his duties as a Trainer. The Stewards therefore fined Trainer Keith Lucas \$300.00 and advised him that any recurrence of dereliction on his part will be referred to the Trinidad and Tobago Racing Authority.
