Stewards' Observations/Objections & Decisions:

The Starter reported that horses **#1 THE FALCON**, **#3 TSUNAMI**, **#4 SYDNEY** had to be re-saddled at the start. The Stewards received a report that Trainer Johnathan Lyder's horses, **#6 SUPREME LEADER** and **#10 SHOWTIME** were both fitted with traction shoes on their front. The Chief Steward examined both horses, consulted with the Official Veterinarian and referred to Condition 16(d) of the Provisional Programme. After consultation with the relevant parties, the Chief Steward allowed both horses to race. The Chief Steward advised Trainer Lyder that he is not to use those shoes in the future.

Stewards' Observations/Objections & Decisions:

The Stewards received the following two (2) objections, (i) Jockey J. Arneaud, rider of #7 **SCHWARZENEGGER**, placed fourth, objected against Jockey Richard Balgobin, rider of # 8 **SECRET PAGES**, placed third, for foul riding around the 600 meter mark (ii) Jockey O. Mohammed, rider of #3 **UKRAINE**, unplaced, objected against Jockey A. Poon, rider of # 6 **RED ALERT**, unplaced, for crossing around the 900 meter mark. The Stewards interviewed all four jockeys and viewed the video replays and overruled both objections and declared the race official.

Jockey Ridge Balgobin, rider of # 9 **HOT ROD KASHTON**, placed second, was severely cautioned by the Stewards for prematurely easing his mount before the finish line.

Jockey **N. Mohammed** was unable to fulfill his riding engagements. He must produce a medical certificate of fitness before booking rides in future.
