Stewards' Observations/Objections & Decisions:

The Stewards called an inquiry into the running of the race. The Stewards received the following objection: **Jockey D. Khelawan**, rider of **#3 PRINCESS ROYAL**, placed second, objected against **Jockey Ridge Balgobin**, rider of **#1 MIA'S CAT**, placed third, for foul riding in the final 200 meters. The Stewards also interviewed **Jockey A. Poon** rider of **#4 EL CHICO MALO**, winner. The Stewards viewed the replay in the presence of all three jockeys who confirmed that **#1 MIA'S CAT** shied from **#4 EL CHICO MALO**, and onto **#3 PRINCESS ROYAL**. The jockeys were reminded to exercise caution. The Stewards overruled the objection and declared the race official.

The Stewards saw no reason to take any action, overruled the objection and made the race official.
