Stewards' Observations/Objections & Decisions:

Mr. Robert Bernard declared an interest in the race and recused himself. Mr. Jeffery Francis acted on his behalf. The Stewards received the following objections Jockey J. Boodramsingh rider of #6 VALIANTE placed third objected against Jockey N. Abrego rider of #4 FREE PASS for crossing at the top of the straight and Jockey R. Jadoo rider of #5 SYDNEY placed fourth objected against Jockey J. Boodramsingh rider of #6 VALIANTE for crossing at the top of the straight. The Stewards interviewed all three jockeys and viewed the replay in their presence. The Stewards observed #4 FREE PASS drifted in on #6 VALIANTE who in turn drifted in on #5 SYDNEY. Jockey Abrego explained #4 FREE PASS was on the wrong lead and was not changing his lead despite his efforts. All three jockeys agreed that the interference was minimal and the Stewards overruled both objections and declared the race official.

Permission was granted by the Stewards for #1 TWITTER KING to be loaded on the outside. The starter informed the stewards that #7 UKRAINE had to be resaddled at the start. The Official Veterinarian reported that #3 NUCLEAR WAR returned lame Right Front Limb (Grade 4).

Jockey O.Mohammed was unable to fulfill his riding engagements. He must produce a medical certificate of fitness before booking rides in future.
