The Stewards received the following objection: **Jockey J. Arneaud**, rider of #4 ZEE ZEE, placed second, objected against **Jockey D. Khelawan**, rider of #3 BRUTAL EXECUTION, winner, for crossing at the start. Upon viewing the replay in the presence of both jockeys, the Stewards observed that #5 UNCLE BEN drifted inwards into the path of #4 ZEE ZEE. The Stewards overruled the objection and declared the race official. The Stewards cautioned **Jockey N. Abrego** rider of #5 UNCLE BEN to maintain proper control of his mount especially coming out of the gates.

The Stewards received the following objection: **Jockey B. Boodramsingh**, rider of #4 THE GODDESS NIKE, placed third, objected against **an unidentified horse**, for foul riding out of the boxes. Upon viewing the replay, the Stewards observed that both #3 STRIKING CHROME ridden by **Jockey R. Jadoo** and #6 MIA'S CAT ridden by **Apprentice Jockey S. Sookhan**, drifted outward and inward respectively, thereby tightening up #4 THE GODDESS NIKE. The Stewards viewed it as accidental and cautioned both jockeys to exercise better control of their mounts, coming out of the gates. The Stewards overruled the objection and declared the race official.
